Terms: There will be no presumption by you that any credit or special terms have been extended to you by Consolidated Press. A request to establish credit with us begins with a fully completed credit application well enough in advance of the project to adequately process. Our standard terms require you to make payment in full within 30 days after completion of production or 15 days from the date of invoice, whichever is later, unless otherwise agreed. Finance charges of 1 1/2% per month will apply to any unpaid balance over 30 days. Special terms, including deposits and partial payments, will be arranged based on individual circumstances. Partial or monthly payments will be required on prolonged production. As security for payments of any sum due or to become due under the terms of this agreement, we shall have the right to retain possession of and shall have a security interest in all property owned by you and in our possession. All accounts are due and payable at the address shown on the invoice. Applicant further agrees to pay reasonable attorney fees in the event suit or action is commenced to secure payment of any sums due under this agreement.

Guarantee, Liability Limitations, Indemnification: We will produce this work in a good workmanlike manner and in accordance with the agreed upon specifications and production schedule. In the event the work is defective or delayed due to our fault, our liability to you shall be limited to reimbursement of amounts paid by you and we shall not be responsible for special or consequential damages, including, but not limited to, lost profits or business. Any controversy or claim arising out of or relating to this contract, or the breach thereof, shall be settled by arbitration in accordance with the Rules of the American Arbitration Association, and judgment upon the award rendered by the Arbitrator(s) may be entered in any court having jurisdiction thereof. Any claims made by you must be in writing and given to us within 15 days after shipment of work. You warrant that the use of materials furnished by you will not infringe or violate any laws or regulations or any rights of others and you will indemnify and save us harmless from any and all damage, cost and expense based on any claims of such infringement or violation, including court costs and attorney's fees.

Governing Law: This agreement shall be deemed as to have been executed and performed in the State of Washington and shall be governed by the laws thereof. Regardless of origin, any applicable Federal, State, County or local taxes imposed on us on account of this transaction shall be added as an extra charge. If sales tax does not apply to this order, please include a completed tax exemption form with your order, otherwise sales tax will be charged. If after your invoice is paid, it is determined that more tax is due, then you must promptly remit the required taxes to the taxing authority, or immediately reimburse us for any additional taxes, interest or penalties.

In consideration of the extension of credit to applicant, applicant agrees to pay all invoices when due according to the terms set forth on such invoices.
